

Anne works closely with companies to determine which regulations may affect their transactions; obtain necessary government approvals related to the import, export, or transfer of their products, software, technology, and services; design and implement internal compliance programs; conduct compliance assessments; train employees on regulatory compliance issues; and, when necessary, conduct internal investigations and prepare voluntary disclosures.

Anne assists clients as new regulatory challenges arise, including adapting to new sanctions regimes, classification of "critical technologies" as they may apply to CFIUS analyses, and obtaining of "deemed export" licenses for clients that employ visa holders in export-controlled areas. She also assists clients with import-related matters, such as evaluating supply chains, responding to CBP inquires and actions, duty assessment, Harmonized Tariff Schedule classification, country of origin determination, and valuation.
