 Defending Google against monopoly maintenance claims arising from search promotion agreements with Apple and Android OEMs brought by the Department of Justice. Previously represented Google in investigations of search, advertising, and mobile businesses in the United States, Europe, Brazil, and India.

- Defended the T-Mobile/Sprint merger through review by the DOJ and FCC and suit brought by a coalition of state attorneys general to block the deal. The district court approved the merger.
