Select Representations

- Obtained a complete plaintiff-side verdict for VB Assets in a multi-patent case against Amazon and its Alexa/Echo virtual assistant and voice commerce platform. After a one-week trial, the jury found that Amazon willfully infringed all four asserted VB Assets patents and awarded \$46.7 million in damages. Law.com named the case among its “Top 100 Verdicts for 2023.”
- Obtained a complete defense verdict for Aadi Bioscience in a \$340 million ICC arbitration arising out of claims that Aadi breached its duties under a drug development and licensing agreement. In September 2024, the panel issued a 60-page [ruling](#) finding that Aadi had not breached the contract.
- Defending OpenAI in a first-of-its-kind litigation in which the plaintiff alleges that he was defamed by output from ChatGPT.
- Defending global retailer in putative nationwide class action litigation pending in federal court regarding allegations that “was/now” pricing misleads consumers.
- Secured a victory at trial for the owners of Santa Anita Race Track in litigation arising out of the 2019 horse racing fatality crisis.
